Begin your day with a **guided tour** of the **Liberty Aviation Museum** which showcases **military uniforms, historical aircraft & military vehicles**. Next, you will have the opportunity to **meet 98 year old Dr. Harold Brown**, one of the last remaining **Tuskegee Airman**. He will **share stories** of his childhood and how he **fulfilled his impossible dream** to fly for his country. After lunch, enjoy a **guided tour** of the **North Coast Veteran's Museum**. **U.S. military history comes alive** during your visit with local **military uniforms and memorabilia** on display. Visit the **9/11 Public Safety Service Memorial** which is **made from steel that was recovered from the World Trade Center**. Hear how the memorial was created & how it was **brought to the village of Gibsonburg from New York**. End your day at the **Historic Gibsonburg Barn 9/11 Memorial** that **honors residents who died on 9/11 as well those in public service who risk their lives to keep us safe**.
